Item 2.01. Completion of Acquisition or Disposition of Assets.

On June 3, 2019, Famous Dave's Ribs, Inc., a wholly-owned subsidiary of Famous Dave's of America, Inc. (the "Company") completed the acquisition of a franchised Famous Dave's restaurant in Grand Junction, Colorado (the "Grand Junction Purchased Restaurant"). The seller of the Grand Junction Purchased Restaurant was Mesa Mall BBQ, Inc., which was a franchisee of the Company. The acquisition of the Grand Junction Purchased Restaurant was pursuant to a previously announced asset purchase agreement for five Famous Dave's restaurants in Colorado. The purchase price of the five Famous Dave's restaurants in Colorado was approximately \$4,100,000, exclusive of closing costs, plus an amount equal to the book value of the restaurant inventory, plus the assumption of the gift card liability associated with the five Famous Dave's restaurants in Colorado. The completion of the acquisition of the first four restaurants took place on March 4, 2019.
